Mr. Harold Herring reminded the Board that as of July 1, 2016 the allotment of water will be reset.

Mr. Harold Herring spoke of his and Mr. Charlie Colie's trip to Chicago, IL to the National AWWA Convention this past Monday where they entered water from NRWASA in the National Best Tasting Water Contest. Although NRWASA did not win, they had a very rewarding trip.
